

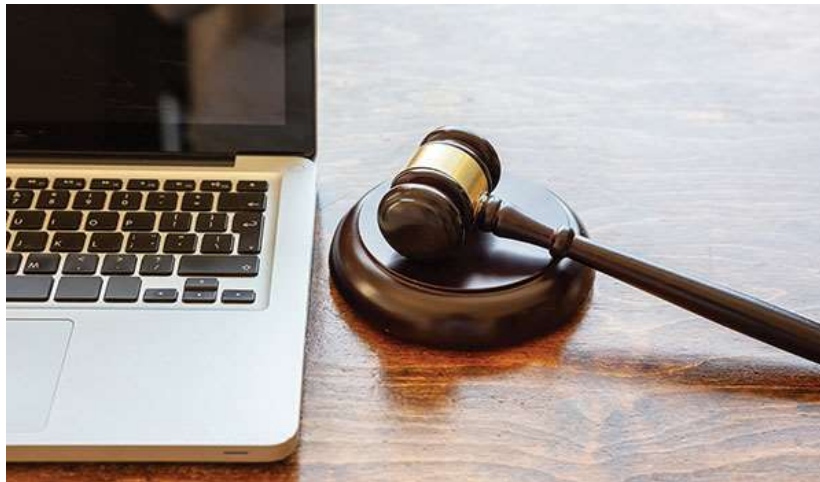

Lord Lloyd-Jones, Justice of the Supreme Court. Lord Lloyd-Jones is a British judge and legal scholar. He is currently a Justice of the Supreme Court of the United Kingdom and served earlier as a member of the Court of Appeal of England and Wales and as a chairman of the Law Commission. In 2005, he was appointed as a High Court judge, and was assigned to the Queen's Bench Division. He served as presiding judge on the Wales and Chester Circuit and chairman of the Lord Chancellor's Standing Committee on the Welsh Language from 2008 to 2011. On 1 October 2012, Lloyd Jones was appointed a Lord Justice of Appeal, and was appointed to the Privy Council on 7 November 2012.
