President of the England & Wales section of the Franco-British Lawyers Society and Senior Lecturer at Westminster Law School, University of Westminster, admitted to the New York and Paris bars, practised corporate and commercial law in international law firms.

Lord George Leggatt,



The Right Hon Lord Leggatt is a Justice of the Supreme Court of the United Kingdom. He practised as a barrister for 28 years, specialising mainly in commercial cases, and was appointed a QC in 1997. In 2012 he was appointed a Judge of the High Court, where he sat in the Commercial Court as well as in a wide range of other civil cases and serious criminal cases. He was promoted to the Court of Appeal in 2018 and became a Justice of the Supreme Court in April 2020.

François Ancel, is a judge at the *Cour de cassation*. He was President of the International Commercial Chamber of the Paris Court of Appeal (ICCP-CA) from September 2018 to August 2022. Before September 2018, he was President of the Third Chamber of the Paris *Tribunal de Grande Instance*, which has jurisdiction in intellectual property law. Between 2005 and 2015, he was appointed to the French Ministry of Justice, where he held several positions, including for six years at the head of the civil law section. He contributed to the drafting of numerous civil laws (family law, contract law, procedural rules and nationality) and in particular to the French reform of arbitration, as well as the French reform of contract law and obligations. Previously, he was a judge in several lower instance courts (*tribunal d'instance* and *tribunal de grande instance*) between 1996 and 2005 where he handled a wide variety of civil cases.

Lord Ericht,



(Andrew Stewart) was appointed as a judge of the Scottish Supreme Courts in May 2016 and is currently a Commercial Judge in the Court of Session. He is also a judge in the UK Competition Appeal Tribunal and the UK Upper Tribunal (Tax and Chancery Chamber) and a member of the Upper Tribunal for Scotland. After working as a solicitor in London and Edinburgh he then became an advocate (Scottish equivalent of a barrister) and was Standing Junior Counsel to the UK Department of Trade and Industry from 2000 to 2009. During his time as an advocate he was one of the elected office-bearers of the Scottish bar (Clerk of the Faculty of Advocates) and editor of *Session Cases*, the official Scottish Law reports. For over 20 years he was a part-time lecturer at the Université de Lorraine, France. He is Vice-President (Scotland) of the Franco-British Lawyers Society and represents the Scottish judiciary on the Franco-British-Irish Judicial Cooperation Committee. In 2019 he undertook a judicial *stage* working at the Cour de Cassation and Conseil d'Etat in Paris. He is an honorary fellow of the Royal College of Physicians of Edinburgh and a trustee of the LawScot Foundation (a social mobility charity) and the Clark Foundation for Legal Education.
